



### 3. MEMBERSHIP:

It is open to all who are interested in the aims and objects of the Committee are eligible for membership into the Society. If any such person wants to become a member of the Society has to apply to the Secretary of the Society along with recommendation of two existing members of the society. All such applications will be scrutinized by the Executive Committee. The decision of the Executive Committee is final in this aspect. There will be an Admission Fee of Rs. 100/- and annual fees is Rs. 25/-.

### CATEGORY OF MEMBERS (handwritten)

#### 4. CESSATION OF MEMBERSHIP

- If any member wants to quit from the Society, he has to give his resignation in writing to the Secretary and such resignation should be accepted by the Executive Committee. Then he will be treated as a non-member of Society.
- If any member fails to attend the meeting of the Society, three times consecutively, his membership will be ceased without any intimation, but he will be reinstated after showing genuine reasons for his absence and such absence should be condoned by the Executive Committee then he will be reinstated as a member of the Society.
- If any member acts contrary to the interests of the Society, he will be removed by the Executive Committee, but such removal should be ratified by the General Body of the Society.

#### 5) GENERAL BODY AND ITS FUNCTIONS

All members of the Society is called as General Body. It is the supreme body of the Society. The decision of the General Body is final in all matters relating to the Society. It will meet atleast once in a year in the month of JUNE to transact the following business.

- to elect the Executive Committee.
- to pass the budget for the ensuing year and approve the expenditure statement of the previous year.
- to appoint an Auditor or Auditors.
- to approve the report of the activities of the society.
- to do any other such business as may be brought before it.

6) EXECUTIVE COMMITTEE AND ITS FUNCTIONS

It will consist of 5 (five) members including office bearers i.e., President, Vice-President, General Secretary, Joint Secretary and Treasurer. It will meet at least once in for every two months or often to see the day-to-day affairs of the Society. It will frame rules for the smooth running of the Society. It can appoint sub-committee for its convenient.

7) DUTIES OF THE OFFICE BEARERS:

PRESIDENT:-

He is the Head of the Society. He will preside over all the meetings of both the bodies of the Societies. He will have supervision over all the affairs of the Society. He can have casting vote in a tie position.

VICE-PRESIDENT

In the absence of the President, he will act as President by the decision of the Executive Committee. He will assist the President in discharging his duties. He will also do the work as may be entrusted by the President or Executive Committee as the case may be.

GENERAL SECRETARY

He is the Chief Executive of the Committee. He is the correspondent on behalf of the Society. He is the custodian of all records, relating to the Society. He has to convene both the bodies of the Society for its meetings with the consent of the President or Executive Committee as the case may be. He has to record the minutes of all the meetings of the society. He has to prepare both the budget and expenditure statements of the Society to put before the General body in the Annual meeting for its approval. He will also do the work as may be entrusted by the Executive Committee from time to time.

JOINT SECRETARY

He assists the General Secretary in all matters and discharges the duties of the Secretary in his absence.

TREASURER

He is the responsible person for all money relating to the Society. He has to collect or to arrange for the collection of subscriptions from the members and keep them in any Bank, jointly with Secretary or President as may be decided by the Executive Committee from time to time. He has to operate all such cash balances from the Bank jointly with the President or General Secretary as may be decided by the Executive Committee from time-to-time. He has to maintain accounts properly along with vouchers and submit them to the Executive Committee for its checking as and when asked by the Executive Committee.

8) QUORUM

Half of the total members for General Body meeting and 1/4th for executive body meeting. No quorum is necessary for the adjournment of the meeting.

11) WIND UP
